

SECTION 1.-ORGANIZATION

This Board shall be composed of all duly qualified (and regularly) approved members currently in good standing with this Board. A member in good standing is defined as having met all financial obligations, having attended a NJSIAA/IAABO sanctioned high school rules interpretation meeting for New Jersey, (a) registered with NJSIAA, (b) passed NJSIAA Background check,(c) completed Concussion Course with verification, (d)reviewed Independent Contractors Agreement,(e) Code of Ethics, and (f)Discrimination Policy, (D,E,F, Posted on www.board34.com) (g) complete NJSIAA Mandated Bias Training (h)completed all IAABO and Board 34 Training Requirements (D,E,F, Posted on www.board34.com) and having met all other meeting requirements and not on disciplinary probation or suspension for the current year. Members will also complete a rules refresher examination annually. A member transferring to Board 34 from another state would be an exception. The current year being defined as JUNE 16th thru June 15th of the subsequent year.

Rationale- add in Bias requirement and IAABO & Board 34 training requirements.

Article VIII-Meetings

Section 1-NUMBER OF MEETINGS

There shall be a minimum of five (5) meetings during a season, which includes the NJSIAA Mandatory Interpretation meeting. If a member attends an NJSIAA Interpretation meeting other than the Board 34 NJSIAA Interpretation, said meeting **WILL NOT COUNT** (change to Count) as a Board 34 meeting. The Annual Banquet is not a meeting and does not count towards attendance requirements.

Rationale- As long as a member attends Interp. meeting

SECTION 3 • ATTENDANCE

Active members must attend at least four (3) meetings, one of which must be an IAABO/NJSIAA New Jersey sanctioned rules interpretation meeting.

Rationale- correct to right # of meetings that was approved prior. Clerical error

SECTION II - HOW TO APPLY

Applicants for active membership shall indicate their desire to the Board Secretary and shall successfully pass the following requirements and be eighteen (18) years of age or over. A. Establish a satisfactory record of health and character.

A. Establish a satisfactory record of health and character.

Must participate a minimum of two years in a Cadet program and during those two years attend at least 80% of the meetings held for Cadets and Transfers from a non-IAABO Board (with certification within the past two (2) years) and satisfy Section II (C) and (D) below.

Pass the International written examination (Delete) ADD: "IAABO U and any all associated modules administered by Board 34

- B. Pass the International practical floor test approved by the Executive Committee ADD: administered by Board 34)
- C. Successful completion of a background check (to include any local, state, or national requirements)
- D. Work a combined minimum of eight (8) non-school 7 school games per year while in Cadet program.
- E. Volunteer work (requirements determined by Cadet Supervisor)
- F. Sign/Acknowledge Discrimination Form.
- G. Sign/Acknowledge Sexual Harassment Form
- H. Must receive approval of the Executive Committee to attain active member status.
- I. Must register with NJSIAA.
- J. Complete mandatory NJSIAA Bias Training (ADD)

Rationale- To align with new IAABO Procedures and NJSIAA Bis Requirement
